## CAPE COD GATEWAY AIRPORT SEEKS COMMUNITY INPUT ON DEVELOPMENT OF 20-YEAR MASTER PLAN

**HYANNIS, MA** (March 10, 2021) – Cape Cod Gateway Airport (HYA), formerly Barnstable Municipal Airport, is requesting community input on the development of their 20-year master plan to ensure that the facility can continue to safely and efficiently meet the aviation needs of the surrounding community.

"Cape Cod Gateway Airport has embarked on the development of a 20-year master plan to ensure that the facility can continue to safely and efficiently meet the aviation needs of the National Airspace System and the surrounding community," explained Airport Manager Katie Servis. "The preparation of an airport master plan is required by the Federal Aviation Administration (FAA) in order to plan for the future and highlight airport projects needed in the future to meet demand, including rehabilitation of existing infrastructure. "The plan is a comprehensive study of an airport that considers the needs of the airfield, local general aviation, corporate aviation, commercial aviation and the community over the next 20 years as well as including recommendations for promoting compatible land use around the airport and to maximize opportunities to help support the airport's financial future."

"Stakeholder input is an important part of the master plan process," said Manager Servis. "Typically we hold a series of in-person meetings, but with the ongoing Covid-19 pandemic and in the interest of public safety, we have placed the content for the public workshops on our YouTube channel." The airport's YouTube channel (<a href="https://bit.ly/HYAmasterplan">https://bit.ly/HYAmasterplan</a>) features presentations from previous project stakeholder meetings, divided by topic area into short, narrated videos for the public



to watch and share. In addition, a dedicated e-mail address <u>HYAMasterPlan@mjinc.com</u> has been set up to receive questions or comments from the public regarding the master plan for the airport. The second public workshop will be held live via Zoom.
